CATEGORY DESCRIPTIONS

Commercial Entry: All business entries including floats, walking, and vehicles. Non-commercial Float: All groups, families, community organizations, and clubs with a vehicle/truck/trailer. May include

riders and walkers. Small-Group Walking: Walking groups with 1-19 participants without vehicles.

Large Group Walking: Walking groups with 20 or more participants without vehicles.

Animal Walking Group: Animal groups including clubs and equestrians without a vehicle.

Government: All government and military entries.

Car Club or Motorcycle Club: Up to 6 cars or 12 motorcycles.

Miscellaneous: Doesn't fit in a category.

RULES AND REGULATIONS

Ghouls on Parade is meant to be fun for the community; however, our priority is safety for both parade entrants and spectators.

1. ENTRIES: A maximum of 50 entries will be accepted at the parade. FIRST COME, FIRST SERVED.

2. <u>CAR CLUBS</u>: The number of Car/Motorcycle Clubs will be limited to 5. Additionally, the number of cars per club is limited to 6. (Different chapters of the same club will not be accepted.) There is a limit of 12 motorcycles per Motorcycle Club.

3. **<u>MUSIC</u>**: Music is encouraged at a reasonable volume; however, sound systems may not be used for broadcasting messages or agendas.

SIZE: There is no limit to the length of the entry, but height cannot exceed 14 ft. to fit under the street lights.
MATERIALS: All materials used must be flame retardant. A properly rated, currently tagged fire

extinguisher is required for each applicable entry. All wiring must be secured to prevent personal injury and equipment damage. All connections must be made with UL-approved electrical boxes and devices. Portable generators/compressors must be securely mounted, and a minimum distance of one foot from any combustible material. Generators/ Compressors must be equipped with firmly attached exhaust systems that terminate into a common exhaust serving the vehicle or in the same manner as vehicle exhaust. Insurance and liability are the sole responsibility of the entrant. The Fire Marshal will have the final say on all regulations.

6. **<u>HANDOUTS</u>**: Hurling of any items is strictly prohibited. <u>**PLEASE DO NOT HURL CANDY**</u>. Candy may be handed to or tossed gently underhand to attendees. Walking entrants may hand out appropriate items.

7. **ANIMALS:** All animal entries must provide their own person to pick up animal waste during the parade. All dogs must be on a leash during the duration of the parade.

8. **MANDATORY MEETING:** A mandatory meeting will be held for all entries sometime in October. The place and time will be announced at a later date (subject to change).

9. **RULES SUBJECT TO CHANGE:** All rules and regulations are subject to change at any time without notice. Participants will be informed of any updates.

I have read the attached Rules and Regulations and agree to abide by them. I understand that instructions by Parade Staff must be followed at all times and violations will result in immediate disqualification.

FOOD VENDORS: We do not accept vendors of prefab or commercial goods. A <u>\$50 booth fee for business vendors</u> or a <u>\$25 fee for food trucks</u> must accompany all applications by October 7, 2023. Spaces may be shared, but all Vendors must fill out an application.

Electricity is NOT provided by Graphicbliss LLC. Vendors must provide their own canopies, tables, chairs, electricity, lighting, and weights. Each vendor must provide Graphicbliss LLC dba New Mexico Entertainment Magazine with Certificates of Insurance, Business Licenses, and Fire and Food Permits. All COIs and Permits must be sent to <u>nmentertains@gmail.com</u> with the email subject line including "[Your Vendor Company Name] insurance forms and permits." Submit paperwork along with your application no later than September 30, 2023.

DUE TO CITY REGULATIONS, EACH POST OF VENDOR TENTS MUST HAVE 50lbs OF WEIGHT PER POST EQUALING A TOTAL OF 200lbs OF WEIGHT PER CANOPY FOR SECURITY IN CASE OF INCLEMENT WEATHER AND WINDS! IF YOU ARRIVE WITHOUT THE PROPER WEIGHT REQUIREMENTS YOU WILL NOT BE PERMITTED TO SET UP AND YOU WILL FORFEIT ALL BOOTH FEES. NO EXCEPTIONS WILL BE MADE! NO STAKING IS PERMITTED.

No Refunds will be given for any reason including booth placement locations.
